

TERMS AND CONDITIONS

Definitions

- 1. The name of the Collaboration shall be OneSMP LLP (hereinafter the "Collaboration").
- 2. Collaboration Firm includes the entity who has signed up the application form and applying, and accepted to join all successors and affiliates to that entity and additionally any holding or subsidiary entities and entities controlled by the subscribing Collaboration Firm and also any entities under common control. Any decision on the extent of this definition for a Collaboration Firm is at the discretion of OneSMP LLP.
- 3. Domicile of OneSMP LLP shall be in Singapore.

Matters Affecting Collaboration Firms

- 4. OneSMP LLP, as a separate entity, is not in the business of offering auditing, consulting, advisory or compliance services. It is formed solely for the purpose to facilitate the exchange of professional information, assistance and the referral of clients among its partners in the field of auditing, tax, business consultancy, advisory, accountancy and compliance services.
- 5. A Collaboration Firm shall be permitted to consult any other Collaboration Firm on professional matters and the Collaboration Firm so consulted may charge an appropriate fee to the other Collaboration Firm but such fees shall be subject to mutual agreement.
- 6. Admission of Collaboration Firms
 - a. New applications shall be considered for acceptance or rejection by OneSMP LLP.
 - b. The application may include an inspection visit to the principal offices of the applicant Firm.
- 7. No Collaboration Firm may act on behalf of OneSMP LLP without the express written consent.

Resignation and Expulsion

- 8. Any Partner Firm may resign from OneSMP LLP by sending a written notice to OneSMP LLP. Such resignation will become effective on January 1 of the following year.
- 9. Loss of accreditation or loss of right to practice as professional business consultants and advisors by a firm or a majority of its owners in its country of practice automatically terminates collaboration of the firm in OneSMP LLP.
- 10. When a Collaboration Firm ceases collaboration with OneSMP LLP, it shall forthwith stop using the name of OneSMP ASEAN (or any similar name) and/or logo on its letterhead.

Annual Fees and Fees for Services

- 11. In January of each year, every Partner Firm will be invoiced for annual dues and shall pay such annual dues within 30 days of the invoice date as a contribution towards the expenses of OneSMP ASEAN.
- 12. A Collaboration Firm shall charge normal fees to clients introduced to it by other Collaboration Firms and shall notify the client and other Collaboration Firm of the fees to be charged. This does not obligate, entitle or prohibit any Firm to profit-share with any other Firm, or to any other financial commitment with another Firm, except as specifically set forth in this Terms and Conditions.
- 13. OneSMP LLP may recommend changes to the fee structure or adjust the annual dues of a collaboration firm.
- 14. Collaboration Firms must report details of referrals received and given to and from other Collaboration Firms to OneSMP LLP within thirty (30) days of 30 June and 31 December in each year. If they fail to do so within sixty (60) days, a penalty may be imposed as determined by OneSMP LLP. Failing to report details of referrals for two (2) consecutive periods constitutes grounds for collaboration termination, However, final collaboration termination is at the discretion of OneSMP LLP.

Use of the Name and Logo of OneSMP ASEAN

15. Use of the Rights

- a. The conditions under which OneSMP ASEAN name and logo and the registered trademarks and other proprietary data ("Proprietary Data") belonging to OneSMP LLP used by Collaboration Firms shall be determined by OneSMP LLP.
- b. A Collaboration Firm may use the logo OneSMP ASEAN and the words "Collaboration Firm of OneSMP ASEAN" on its letterheads, business cards and other promotional literature.
- c. The use of the Proprietary Data may be expanded (Expanded Rights) under the sole authority of OneSMP LLP. However, the Proprietary Data may only be used in connection with the members' business activities as permitted by the licensing body of the jurisdiction in which the member is situated.
- d. The rights are granted only if, and as long as, the Collaboration Firm is not threatened by bankruptcy, winding-up or liquidation. Should the Collaboration Firm be threatened by any of these contingencies, the Collaboration Firm is responsible for immediately informing OneSMP LLP and ceasing to use any of the Proprietary Data.

16. Termination of Rights

- a. The right to use the Proprietary Data expires upon the termination of collaboration in OneSMP ASEAN.
- b. OneSMP LLP has the power to withdraw the right to use the Proprietary Data in the following instances:
 - i. If the Collaboration Firm is in the process of winding-up or liquidating its business or is in risk of imminent bankruptcy;
 - ii. If the Collaboration Firm uses the Proprietary Data in a manner which may be considered an abuse of the rights herein granted and which may bring disrepute or incur legal liability to the OneSMP LLP;
 - iii. If the annual dues are not paid by the Collaboration Firm; and
 - iv. If determined by OneSMP LLP.

17. Breaches of Terms and Conditions

- a. Breaches of this Terms and Conditions shall be referred to OneSMP LLP who shall deal with the matter.
- b. Collaboration Firms violating this Terms and Conditions will also be responsible for the reasonable legal and other related costs incurred by the OneSMP LLP in enforcing this Terms and Conditions as a result of such violation(s).

Interpretations and Dispute Resolution

- 18. This Terms and Conditions shall be interpreted in accordance with the Laws of Singapore.
- 19. Nothing contained in this Terms and Conditions nor any arrangement between Collaboration Firms shall be construed as a partnership among all or any of the Collaboration Firms.
- 20. The decision of OneSMP LLP is final.
- 21. Any dispute, controversy or claims between Collaboration Firms arising out of or in connection with the present OneSMP LLP terms and conditions or their collaboration in OneSMP LLP shall be settled by arbitration according to the Singapore Law.
